Your agency/division can also provide a resource table with information of your organization to the public.

We thank you for participating and for helping make this Halloween a fun and safe event for our children in our community. Make sure you bring plenty of candy or Halloween trinkets, we are expecting more than 3,000 kids to stop by.

For safety reasons, all display vehicles must remain in the field until the end of the event. No vehicle will be allowed to leave once the event has begun. All candy must be wrapped or packaged. No homemade goods are allowed. **No alcoholic beverages or smoking is allowed at the event.**

Deadline to submit entry is October 23, 2024 at 4:00 pm. **Unregistered vehicles will not be allowed.**
