Purpose:

Designed for field officers who are authorized to carry a tactical rifle. Emphasis on the AR-15/M-16 short barrel rifle. Successful completion of this course satisfies the legislative training mandate to possess short barrel rifles as specified in California Penal Code section 33220(B) and the commission training requirement to possess long barrel rifle as specified in commission regulation 1081.

II. LAW UPDATE (Penal Code and POST mandate 1081 review)

A. Penal Code section 33220(b)

The possession of short-barreled rifles and short-barreled shotguns by peace officer members of a police department, sheriff's office, marshal's office, the California Highway Patrol, the Department of Justice, or the Department of Corrections and Rehabilitation, when on duty and the use is authorized by the agency and is within the course and scope of their duties, and the officers have completed a training course in the use of these weapons certified by the Commission on Peace Officer Standards and Training.

B. Penal Code section 32610(b)

The possession of machineguns by regular, salaried, full-time peace officer members of a police department, sheriff's office, marshal's office, district attorney's office, the California Highway Patrol, the Department of Justice, or the Department of Corrections for use by the department's Special Emergency Response Teams and Law Enforcement Liaison/Investigations Unit, when on duty and if the use is within the scope of their duties.
