

RESOLUTION NO. 07- 100

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
EL CENTRO RESCINDING RESOLUTION NO. 05-94  
AND RESOLUTION NO. 97-9 AND RE-ESTABLISHING  
SANITARY SEWER AND WATER CAPACITY FEES

WHEREAS, the City of El Centro, California, (hereinafter referred to as "City") has adopted Resolution No. 05-94 and Resolution No. 97-9 establishing Sanitary Sewer and Water Capacity Fees in the City, pursuant to Section 24-10(b) of the Code of the City; and

WHEREAS, it is in the best interest of the City to rescind Resolution No. 05-94 and Resolution No. 97-9 and re-establish the fees to be charged for Sanitary Sewer and Water Capacity pursuant to Section 24-10(b) of the Code of the City; and

WHEREAS, the City of El Centro caused a Water and Wastewater Rate Study to be prepared by Nolte, Inc. in 2005; and

WHEREAS, the said study has identified services provided by the City of El Centro for which capacity fees may be established so as to recover the costs reasonably borne by the City in providing such services; and

WHEREAS, said report is on file in the office of the City Clerk establishing that the costs for the services described herein are commensurate with the fees set forth in this resolution; and

WHEREAS, on July 18, 2007 the City Council conducted a duly noticed public hearing on the proposed Sanitary Sewer and Water Capacity Fees; and

WHEREAS, if any provision of this resolution is declared by a court of competent jurisdiction to be legally invalid, or otherwise legally deficient for any reason, then the provisions of Resolution No. 05-94 as applicable to said capacity fees shall not be deemed to have been repealed and shall remain in full force and effect as to said fee; and

WHEREAS, the City Council finds that the procedures prescribed by California Government Code Section 66016 have been satisfied.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF EL CENTRO, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

1. That the foregoing is true, correct and adopted.
2. That Resolution No. 05-94 and Resolution No. 97-9 is hereby rescinded.

3. That the City Council hereby determines that the Sanitary Sewer and Water Capacity Fees shall be based upon an Equivalent Dwelling Unit (EDU) for the following uses:

23.	Administrative review is available for those uses that do not fit exactly within any of the occupancies referenced in items 1 thru 22 above. Administrative review requires an engineering technical study by a registered civil engineer. The City Engineer shall determine the EDU's, with final approval and implementation by the City Manager.			
24.	For items number 6 thru 10, 12 thru 15 and 17 thru 22 above, the calculations will be prorated to determine the EDU. A minimum of 1 EDU will be assessed for all new development which has no prior occupancy use.			

- \* EDU calculation is based on size of lot or land regardless of the size of the unit parked there.
- \*\* Laundry and/or dry cleaner facilities which do not discharge into the City's sewage collection system and/or use recycling of water may be eligible for administrative review.
- \*\*\* For industrial warehouses with one restroom facility 1 EDU will be assessed.

4. That the Administrative review is available retroactively through January 1, 2007 for those uses that do not fit exactly within any of the occupancies referenced in items 1 through 22 above.
5. That the City Council hereby re-establishes the Sanitary Sewer and Water Capacity Fees per EDU which shall be effective upon adoption of this Resolution as follows:
